I, _____ (**Print clearly**) have asked to participate in the Clay Plastering Workshop activities with Harvest Haven Market Farm and Charlie Carruthers, which includes:

1. A project involving physical labour, the operation of hand and power tools, and heavy equipment.
2. Any and all peripheral activities associated with attendance of the above mentioned workshop, including, but not limited to, inherent risks associated with livestock, farm equipment, farm facilities, honeybees, and all other aspects of the workshop environment on a working farm.

I understand that these activities can result in serious injury or death and involve certain risks including, but not limited to inclement weather or equipment failure. I expressly assume these risks. I understand that accidents or illness can occur in locations without medical facilities. I understand that these activities can be strenuous and should not be attempted by persons with heart or vascular ailments. I represent that I am in good health. I acknowledge that the outdoor activities may be more physically demanding than those to which I am accustomed. To the extent that any physical, mental, or emotional disability which would impair my ability to participate in the outdoor activities and exercises described above, I have made written reference to such disability below. In the event I have made no such reference to any such disability, I represent to Harvest Haven Market Farm, Charlie Carruthers, and the facilitators of these activities that I have none.

I expressly assume the risk of personal injury, death, and property damage that may result from my participation in these activities and waive any claims based on negligence or breach of warranty I might assert on my behalf against Harvest Haven Market Farm, Charlie Carruthers, and any officers, directors, agents, and employees of the aforementioned for personal injuries, death and/or property damage sustained while participating in these activities with Harvest Haven Market Farm and Charlie Carruthers.

I also give permission that photo and/or video taping which may be taken of me in workshops may be used in publication for commercial or other purposes.

I further agree on my behalf to hold Harvest Haven Market Farm, Charlie Carruthers, Harvest Haven Market Farm's officers, directors, agents, and employees and the sponsors and property owners, _____, harmless for the personal injuries to others or for property damage which results from my own use of equipment provided by Harvest Haven Market Farm and Charlie Carruthers in violation of any of its rules or the terms and conditions of this agreement.
